A. Information materials related to application for variation of conditions of Security Personnel Permit

有關申請更改保安人員許可證條件的資料

(1) You <u>must</u> read the following materials before submitting the application:

- (a) the Security and Guarding Services Ordinance, Chapter 460, and its subsidiary legislations; and 《保安及護衞服務條例》(第 460 章)及其附屬法例;以及
- (b) Personal Information Collection Statement. 收集個人資料聲明。
- B. Points-to-note when completing the application form 填表須知
- (2) Please complete all parts of the application form and provide as much details as possible. 申請表各部分均須填寫,並須盡量提供詳盡資料。
- (3) The application form should be duly signed. 申請表須簽署妥當。
- (4) Amendments to the information provided in the application form should be duly signed against by the applicant.
